



I, MICHAEL EUGENE PASSMORE, a resident of and domiciled in Escambia County, Florida, being of sound and disposing mind and memory, do make, publish and declare this to be my Last Will and Testament, and do hereby revoke all other wills by me made.

CLAUSE ONE

I desire and direct that my body be buried in a manner suitable to my circumstances in life. I direct that all of my just debts and funeral expenses, and the expenses of my last illness, be paid as soon as practicable after my decease.

CLAUSE TWO

I hereby nominate, constitute and appoint HARRIET . FENTON, and MARION T. FENTON, or the survivor of them, as the personal representatives of this, my Last Will and Testament. I direct that the personal representative of this, my Last Will and Testament, shall serve in such capacity without giving any bond or other security to any court to insure the faithful performance of his or her duties in such capacity.

CLAUSE THREE

I hereby give, devise and bequeath my entire estate, whether real, personal or mixed, wherever situated, of which I may be seized or possessed, or to which I may be or become in any way entitled or have any interest, to my beloved daughter, BELINDA RUTH PASSMORE, provided she survives me. CLAUSE FOUR

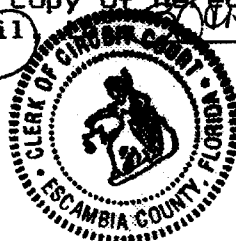

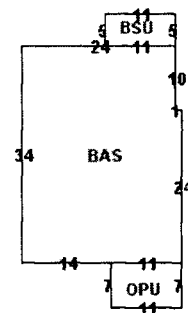
