THIS MORTGAGE ("Security Instrument") is given on this 1st day of July, 2005. The Mortgagor is **Equitable Interest and Investment Corporation**, ("Borrowers"). 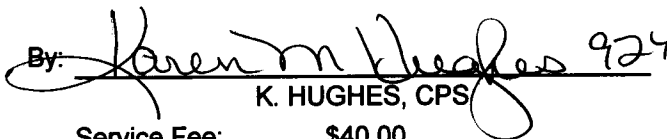
