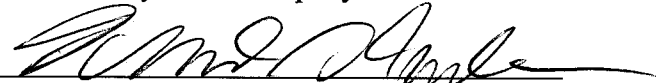

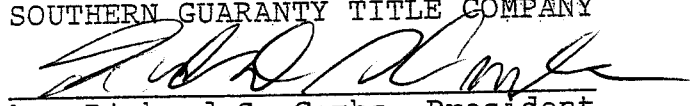

Mortgage and Security Agreement

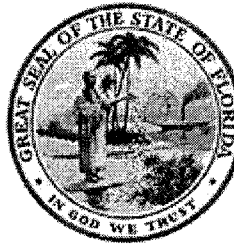

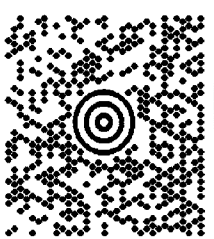
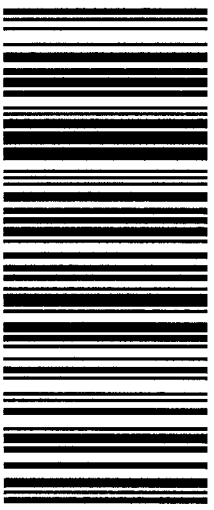
