

Environmental Health conducted an inspection of the Onsite Sewage Treatment and Disposel System (OSTDS) at the above referenced location. The condition(s) stated below outline the department's assessment of the OSTDS:

The premise has been occupied for a considerable time and no overflows were observed at the time of the inspection. The condition of the internal structure of the tank compartment could not be determined because the tank was not opened for a visual inspection. A limited external inspection of the tank did not reveal any structural deficiencies. However, moderate to severe not intrusion was found in close proximity to the tank compartment. This root intrusion may have strared the integrity of the tank compartment; therefore, we recommend that an authorized contractor inspect the internal structure of the tank. The inspection, if conducted, is at the property owner's expense. A copy of the certification should be faxed (595-6777) to Environmental Health.

The drainfield system was probed and the soil adjacent to the drainfield was augured to assess the system's functionality. Moderate to severe root intrusion was also found in the drainfield areas that could after the system's functionality in the future. However, the system appeared to be operating properly at the time of our inspection.




