

FINAL JUDGMENT

At a hearing in open court on February 14, 2017, the parties appeared representing themselves. Plaintiff filed this lawsuit to recover monies advanced to the church for the purchase of a van on September 6, 2015. It is undisputed that on September 6, 2015, the church announced that they needed to purchase a van to replace one of the two vans the church owned which was no longer "fixable." The goal was to raise \$30,000.00 and pay cash for a van. The plan was to have at least 30 members of the church give \$1,000.00 each not later than January, 2016. The challenge was to either pay \$1,000.00 or \$200.00/month over the five months ending in January with the purchase of the van. The plaintiff wrote a check for \$1,000.00 that day. She gave the money with the condition that it be used to purchase the van or returned to her because she was unhappy that an earlier contribution of \$650.00 to fix the water system was not used for that purpose and the water was never fixed.

In January, Brother Charlie McCants announced that there was a delay in fund raising but that the van would be purchased not later than April, 2016. The plaintiff agreed to the delay. When the funding raising stalled, the defendant, through the chairman of the Trustee Board, assured the plaintiff that the van would be purchased or she would received a full refund on her request. The plaintiff then granted an extension until August. By August, she demanded her money back. The Chairman of the Trustee Board, Joe Mack, refused. He explained to her that the money was a "donation to the church" which was not refundable.

On behalf of the church, Joe Mack testified that as of this point, only about \$15,000.00 has been raised towards the purchase of the van. The project is still on-

going, and that they will raise the money and purchase the van. He was unable to produce any proof that the money is being held "in escrow" for the purchase of the van. He was unable to explain the delay or project when, if ever, the money would be sufficient for the purchase. Certainly the monies "collected" so far would only cover about half the required amount for the purchase. He could not testify about any fund raising projects or plans to raise money to complete the project. He basically talked about other problems and distractions which put this van purchase project to the side while other more pressing matters were handled. It has now been nearly 18 months since the plaintiff advanced \$1,000.00.

The plaintiff contracted with the defendant to provide \$1,000.00 towards the purchase of a church transportation van on September 6, 2015. The terms of the contract required the church to use the money for the purchase of a van. This verbal contract was modified in January, 2016, to extend the time to purchase the van from January to April. In April, the plaintiff granted an additional modification extending the time to August. The defendant breeched the contract by not making the purchase and therefore must return the money.

ORDERED AND ADJUDGED that the plaintiff shall recover from the defendant \$1,000.00 plus court costs of \$265.00 all of which shall accrue interest at the rate of 4.97% for which let execution issue.




