

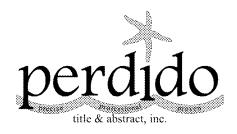

#### **CONSENT TO LIEN AND WAIVER OF RIGHTS**

I, Otis M Pickett Jr. have read the proposed order of the Special Magistrate for the Escambia County Office of Environmental Code Enforcement. 


