At a final hearing in open court on September 30, 2010, the parties appeared representing themselves—the plaintiff appearing telephonically. Plaintiff sued defendant in an Amended three-count Complaint filed July 12, 2010, seeking a refund of pre-paid rent in the amount of \$250.00 plus compensation for his personal belongings which he feels defendant wrongfully withheld from him and \$200.00 in reimbursement for an ink cartridge he purchased at defendant's direction and installed in her computer.

It is undisputed that defendant rented a room in her home to plaintiff. From the credible evidence presented, the court finds that after plaintiff had been living there for a period of time, defendant discovered that he had stolen a check from her and deposited it into his personal account. She filed charges against him and he was quickly arrested for this theft. At that time, without the statutorily required seven days notice for a weekly rental, defendant terminated his tenancy and for all intents and purposes, locked him out. She placed his personal property in a backyard shed to which plaintiff had a key and notified him to remove his belongings. After three months, she donated the remaining property to Good Will.

As to the termination of tenancy without seven days notice, the court finds that §83.67, Florida Statutes, prohibits the landlord from denying *reasonable* access to the dwelling. (Emphasis added). That is, the question before the court is whether it is reasonable to change the locks and place the plaintiff's belongings into a backyard shed to which the plaintiff has access when the plaintiff is renting only a "room" in the defendant's personal home also occupied by herself and others, when the proof is evident and presumption great that the plaintiff is stealing the personal property of the other occupant(s). Because the plaintiff's actions placed the other renters and the defendant as the co-occupant/landlord at serious risk of further criminal acts, the court finds her actions in terminating the tenancy as she did to be justified and permissible under the residential landlord/tenant statutes.


Furthermore, the court is also convinced by the credible evidence presented, that the monies plaintiff paid to defendant were monies he received from the check he stole from defendant and deposited into his account and therefore no refund would be applicable. Finally,

defendant also proved that she paid to have her computer upgraded and the ink installed so that plaintiff's claim for reimbursement of the ink/installation of the ink is also without merit. Because the plaintiff has the burden of proving his case by credible, admissible evidence and because he failed to do so, it is

ORDERED AND ADJUDGED that plaintiff shall recover nothing from defendant who shall go hence without day.




