



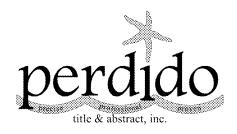

This cause coming before the Court on the Plaintiff, THARP, INC. d/b/a CRDN OF WEST FLORIDA's, Motion for Entry of Final Default Judgment, against the Defendant, PATRICIA HEATH, and the Court having reviewed the Amended Complaint, proof of service on the Defendant, pleadings and affidavit attached thereto, and being otherwise sufficiently advised in the premises, finds that the Plaintiff is entitled to a default final judgment as a matter of law;

THEREFORE, it is;

ORDERED and ADJUDGED, that a Final Default Judgment is entered in favor of the Plaintiff, THARP, INC. d/b/a CRDN OF WEST FLORIDA, against the Defendant, PATRICIA HEATH in the amount of \$13,698.26, which represents the principal in the amount of \$9,156.82; pre-judgment interest in the amount of \$2,472.44; taxable costs in the amount of \$396.50; attorneys' fees in the amount \$1,672.50, bearing interest at the rate of \$% per annum from the date of entry through December 31, 2009, and continuing at each year thereafter at the statutory rate as
