



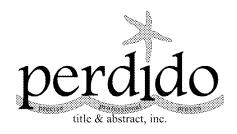

FINAL JUDGMENT
