

FINAL JUDGMENT

At a ZOOM Final Hearing on December 22, 2020, the parties appeared representing themselves. The plaintiff rented a residential property from the defendant and filed this Small Claims case to recover her security deposit. She believes that she is entitled to a full refund of her security deposit and does not understand why the landlord does not return it to her. At the time of the hearing, the defendant/landlord admitted that she had returned nothing because she spoke with the plaintiff/formertenant and when she explained what she was deducting from the deposit, the plaintiff objected and refused to agree to the amount. She decided to hold on to the entire amount until the court case was over. This, of course, is not acceptable and the landlord should have returned whatever amount was not used to repair damages (over and above normal wear and tear) immediately upon reaching a final determination.

That being said, the landlord proved that she had to repair water damage to the floors, change the locks (which had been changed without her permission), repair holes in the walls and repair tub damage for a total of \$690.00. This is the amount she paid to have the damages repaired and she submitted receipts and invoicing to prove this was her cost. It is undisputed that the security deposit was \$1,100.00. Therefore, the defendant should have returned \$410.00.

ORDERED AND ADJUDGED that the plaintiff shall recover from the defendant \$410.00 which shall accrue interest at the rate of 5.37% per annum for which let execution issue.
