PETITION FOR DISCHARGE

Petitioner, Rhonda Baldwin, as personal representative of the above estate, states:

1. The decedent, Hannah Holmes, a/k/a, Hannah Smith Holmes, a resident of Escambia County, Florida, died on June 11, 1968, and Letters of Administration were issued to petitioner on February 1, 2013.
