



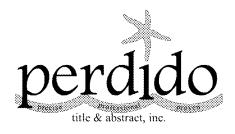

FINAL JUDGMENT

This Cause, came on to be heard upon the Plaintiff's Motion for Final Judgment, and the Court finds that the Defendant, Janice Sheffield a.k.a. Janice F. Sheffield, is indebted to plaintiff in the principal sum of \$9,260.87 plus interest in the sum of \$1,327.25 through July 27, 2004 and prejudgment interest thereafter in the sum of \$226.82. The Court further finds that plaintiff is entitled to recover its taxable costs in the amount of \$275.00.

Additionally the Court finds that pursuant to the agreement between the parties, plaintiff is entitled to the award of a reasonable attorney fee. The Court specifically finds, pursuant to the affidavit of counsel in support of the award, and as required in Florida Patients Compensation Fund v. Rowe, 472 So2d 1145 (Fla 1985), that counsel for plaintiff reasonably expended 3.6 hours of service for its client in this cause. Further, the Court finds the rate of \$225.00 per hour to be a reasonable fee as it is the prevailing rate for similar cases in this community. The Court also determines the contingency risk factor in this case to be 1 resulting in a fee award in the amount of \$810.00.

It is therefore ORDERED and ADJUDGED that plaintiff, Wachovia Bank, National Association f/k/a First Union National Bank, recover from Defendant, Janice Sheffield a.k.a. Janice F. Sheffield, whose Social Security Number is the principal sum of \$9,260.87 plus interest in the sum of \$1,327.25 through July 27, 2004, prejudgment interest thereafter of \$226.82, plus costs herein taxed at \$275.00, plus a reasonable attorney fee in the amount of \$810.00, for a total sum of \$11,899.94, that shall bear interest at the rate of 7% for all of which let execution issue.




