#### **ORDER**

Pursuant to Chapter 30, Article II, Section 30-34, Escambia County Code of Ordinances, this matter, after written notice to all parties, was heard on July 5, 2011, before Robert O. Beasley, Special Master, Office of Code Enforcement Special Master, in the Old County Courthouse, BCC Chambers, 223 South Palafox Place, Pensacola, Florida 32501 upon an alleged violation of the Ordinances of Escambia County, State of Florida, to specifically include Escambia County Codes 42-323, 82-228, 4.01.02 and 30.33.

#### B. Statement of the Case

The matter came to hearing upon a Notice of Violation issued June 14, 2011. Exhibits A-E and Exhibits 1-10 were submitted by the County and Exhibits 1-5 were submitted by the Respondent. In addition, the Respondent presented various letters from the Department of Environmental Protection ('FDEP") which were reviewed and returned. Included in these exhibits was an Order of the Special Magistrate dated July 22, 2008, ("2008 Order"), which specifically addressed the same issues presented in the current Notice of Violation. The primary issue presented by Escambia County was the use of the property as a C&DD disposal facility and also ongoing reclamation mining activities without the proper local permits pursuant to 82-228,

LDC. The representative of Respondent, Anthony Green, did not deny that the property was being used to:(1) deposit for short period storage full and empty roll off dumpsters;(2) dumping of natural vegetation from land clearing activities;(3) dumping of construction materials such as wood from demolished homes;(3) dumping of asphalt and rock materials and (4) excavation of an existing landfill site. It is not clear from the testimony what the Respondent is doing with the excavated materials on the site but the ongoing excavation with large digging equipment is undisputed. The neighbors testified that the noise and dust from this excavation is a nuisance.

The Respondent claims to have secured all necessary FDEP permits to legally dispose of yard trash on the site and to excavate sand materials from the ground. Some evidence was presented by way of letters from the FDEP which referenced these permits, or the need to renew same, but the actual permits were not produced. It is impossible to conclude that all appropriate and necessary permits required by the FDEP have been secured for these activities, or whether additional permits are required for the other ongoing activities. The Respondent also produced a Development Order issued by Escambia County on April 1, 2009. It was unclear as to whether this Development Order has been subsequently extended. There was no evidence that the Respondent has made any of the improvements described in this Development Order.

The Respondent disagrees with the contention of the County that a local permit for C&DD activities is required for his present activities. There was some debate about whether the materials being brought onto the site are included in the definition provided by Sec.82-225(i), LDC. I find that this broad definition without a doubt covers the materials being deposited on the site and that a local permit is required for such storage, except for the asphalt which may be stored for a period of less than two years for recycling purposes. There is no indication as to how long the asphalt materials have been on the site.

The Respondent has continued all of the described activities for an extended period of time despite his non-compliance with the permitting requirements and his reluctance to complete the DRC process by completing the requirements of the Development Order. This limbo status has been to the benefit of the Respondent and to the detriment of the interest of the neighbors and Escambia County.

#### D. Decision

The Respondent shall immediately cease and desist using the property for the dumping of any of the materials described in Sec.82-225(i), LDC on the property and shall not resume these activities until all permits are obtained, to include any local permits and permits required by the FDEP. The Code Enforcement Officers are directed to take such reasonable measure as necessary to stop the flow of truck traffic onto the site in continuance of this dumping activity. Further, the Respondent shall immediately cease and desist any and all excavation and/or reclamation activities until all permits are obtained, to include any local permits and permits required by the FDEP.

Failure to comply with this Order will result in a fine in the amount of \$500.00 per day, which shall commence on ten (10) days from the date of this Order. The amount of the penalty is justified as this is a second violation and a continuing violation. This Order shall constitute a continuing injunction regarding this activity and the Code Enforcement Officers shall periodically check the property and record an affidavit of violation at any time a violation shall exists. There shall be a \$500.00 fine assessed each time an affidavit of violation is recorded.

A cost award in favor of Escambia County in the amount of \$1100.00 is granted. This fine shall be forwarded to the Board of County Commissioners. Under the authority of 162.09

(1) F.S. and Sec 30-34(d), Code of Ordinances, the Board of County Commissioners will certify


