
CIVIL LIEN

THEREFORE, The Special Magistrate being otherwise fully advised in the premises; it is hereby ORDERED that: Willie E. Bradley shall have until 10/13, 2006 to correct the violation and to bring the violation into compliance. Corrective action shall include:

bring into compliance; removing impoundable vehicles; abating nuisance conditions; removing the structure from property; removing all overgrowth

If you fail to fully correct the violation within the time required, you will be assessed a fine of \$1200 per day, commencing 10/14, 2006.

This daily fine shall continue until this violation is abated and the violation brought into compliance or until as otherwise provided by law. Immediately upon your full correction of this violation, you should contact the Escambia County Environmental Enforcement Office in writing to request that they immediately inspect the property to make an official determination of whether the violation has been abated and brought into compliance.

If the violation is not abated within the specified time period, then the County may elect to abate the violation for you and the reasonable cost of such will be assessed against you and will constitute a lien on the property.

Costs in the amount of \$1,100.00 are hereby awarded in favor of Escambia County as the prevailing party against Willie E. Bradley
