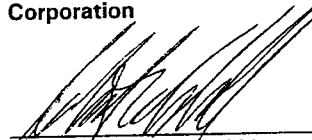

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on this 1st day of July, 2005. The Mortgagor is Equitable Interest and Investment Corporation, ("Borrowers").
