

Defendant Rapid Management Company is a "person" within the meaning of Section 403.031(5), Florida Statutes, and is subject to the provisions of Chapter 403, Florida Statutes, and the administrative rules promulgated thereunder in Fla. Admin. Code Title 62. The use of the word "Defendant" alone in this order refers only to Rapid Management Company. This order does not create any obligation for Defendant Richard S. Straza personally, other than any obligations that may arise due to his capacity as an officer of Defendant Rapid Management Company.
- 4. Defendant Rapid Management Company is a for-profit Texas corporation registered to do business with the Florida Division of Corporations.

- 5. Defendant Rapid Management Company owned and operated a construction and demolition debris disposal facility ("Facility") under Permit Number 0000816-004-SO, known as the Cerny Road facility, located at 3200 Milford Road, Pensacola, Florida at all times applicable to this action.

 Defendant Rapid Management Company has owned the property on which the facility is located since on or about December 13, 1999.
- 6. Ground water sampling conducted by the Defendant on November 2, 2007 and reported in a quarterly evaluation monitoring report dated December 28, 2007 showed concentrations of certain constituents of concern which exceeded Department standards.
- 7. The effective date of this Consent Final Judgment is the date on which it is signed by the Court.

CORRECTIVE ACTIONS, COSTS, CIVIL PENALTIES, AND OTHER TERMS

- 8. Chapter 62-701.730 (10) Fla. Admin. Code and Specific Condition 44 of the permit, requires the owner or operator of the construction and demolition debris disposal facility to undertake long-term care of the facility by monitoring and maintaining the facility for five years from the date of closing unless monitoring or off-site conditions indicate otherwise as determined by the Department.
- 9. Within 180 days of the effective date of this Consent Final Judgment, Defendant Rapid Management Company shall complete the following actions with respect to the Cerny Road Facility:
 - (a) Apply final soil cover to any area that is missing final cover or has subsided in accordance with Fla. Admin. Code Rule 62-701.730(9).
 - (b) Provide seeding or planting of vegetation to the disposal unit in any area where soil cover has been replaced or where vegetation is not established, submit a certificate of closure construction completion and final survey report to the Department in accordance with Fla. Admin. Code 62-701.730(9).
 - (c) Submit long-term care plan to the Department that addresses the requirements of Fla. Admin. Code 62-701.730(10).

- (d) Commence monitoring and maintaining the facility for five years from the date of closing unless monitoring or off-site conditions indicate otherwise as determined by the Department.
- 10. Defendant Rapid Management Company shall allow Department employees, Department representatives, or contractors hired by the Department to have access to the Cerny Road Facility for the purposes of (1) inspecting the current and ongoing environmental conditions at the Property and (2) carrying out any work necessary for closure of the facilities, as required by Rule 62-701, Florida Administrative Code, without the need to obtain prior permission from Rapid Management Company. The Department shall report, by letter, any inspection of the facility by Department employees or contractors. The letter report shall be transmitted with 14 calendar days of access and shall be directed to Jesse W. Rigby, attorney for Rapid Management Company. The Department is authorized to place its own lock on the gate to the facility. This paragraph does not alter any legal requirements of Defendant Rapid Management Company related to the management, cleanup, or closure of the facilities, pursuant to Florida Law, or any lawful Department Order. Defendant Rapid Management shall allow the Department to assist or coordinate any necessary work should funds be obtained for that purpose from insurance proceeds, bond, or other sources or appropriations.
- 11. The Defendant Rapid Management Company must perform the obligations contained in this order to the fullest extent of the company's existing financial ability. If at the time of entry of this judgment the Defendant Rapid Management Company is financially insolvent, then the Defendant Rapid Management Company must immediately perform the obligations contained in this order at any such time in the future as the Defendant Rapid Management Company gains the financial ability to comply with this order. If the Defendant Rapid Management Company sells or disposes of any property or assets, then the Defendant Rapid Management Company must place the net proceeds thereof, after payment of existing priority financial obligations relating to the property sold or otherwise disposed of, into a trust account held for the purposes of compliance with the order. The Department may investigate or document Defendant Rapid Management Company's financial status at any reasonable time or times through the use of all manner of discovery tools provided by the Florida Rules of Civil Procedure.
 - 12. Plaintiff, the State of Florida, Department of Environmental Protection shall recover from

Defendant Rapid Management Company the sum of \$3,500.00 in costs, pursuant to § 403.161, Fla. Stat., for which let execution issue 30 days after the effective date of this order. Interest shall accrue at the statutory rate on any unpaid amount at the rate set by statute beginning 30 days after the date of this Consent Final Judgment.

- All payments are to be made by cashier's check or money order payable to the "State of Florida Department of Environmental Protection." Additionally, the payment instrument should include the notations "Ecosystem Management and Restoration Trust Fund" or "DEP Cost Reimbursement" (for Department costs), and "OGC# 04-1617" thereon. Payment shall be sent to Florida Department of Environmental Protection, Northwest District, 160 Governmental Center, Pensacola, FL 32502.
- 14. Entry of this Consent Final Judgment does not relieve Defendant Rapid Management Company of the need to comply with all applicable federal, state, or local laws, regulations, or ordinances.
- 15. No modifications of the terms of this Consent Final Judgment shall be effective until reduced to writing, executed by the Department and the Defendant Rapid Management Company, and approved by the Court.
- 16. The provisions of this Consent Final Judgment shall apply to and be binding upon the parties, their agents, successors, and assigns.
- 17. If all of the requirements of this Consent Final Judgment have not been fully satisfied,
 Defendant Rapid Management Company shall not sell or convey the Cerny Road Facility without, at least
 14 days prior to such sale or conveyance, (1) notifying the Department of such sale or conveyance, and
 (2) providing a copy of this Consent Final Judgment to the new owner. However, if all the requirements of
 this Consent Final Judgment have been satisfied, Defendant Rapid Management Company shall notify
 the Department of any sale or conveyance of the Property no later than 30 days after ownership has been
 transferred.
- 18. It is further ordered and adjudged that the Defendant Rapid Management Company shall complete under oath Florida rule of civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the Department's Office of General Counsel, within 90 days from the date of the final judgment, unless the final judgment is satisfied or post-judgment discovery is stayed. Failure to complete Form 1.977 as ordered may be considered contempt of court. The Defendant is

required to file a notice of compliance with the clerk of court and serve a copy of the notice on the Department.

19. This Court shall retain jurisdiction to enforce this Consent Final Judgment.

ORDER OF DISMISSAL

20. Pursuant to a joint motion put forth by the Plaintiff and Defendant Richard S. Straza, the Court dismisses with prejudice Richard S. Straza as a Defendant in this proceeding. With respect to this dismissal, each party shall bear their own costs and attorney fees.




