#### ADDENDUM

I. The Court finds that the Respondent/Defendant has an ability to contribute support.

II. The Respondent/Defendant shall reimburse DOR and the custodian for past public assistance obligation, support contributions, medical expenses, administrative costs, if any. Periodic payments shall be made as ordered and shall continue until said sum is paid in full. Respondent/Defendant shall further pay to the Court depository of this County, the designated sum of child support plus the depository service fee each and every period, ending only when the child(ren) is no longer a dependent child unless otherwise directed by this Court. The Court depository shall retain from each payment the service fee for collection and transmittal and transmit the balance to HRS.

III. That the Department of Labor and Employment Security shall deduct up to 50 percent from unemployment compensation benefits that the Defendant may be entitled. This amount should not exceed the ongoing support and/or any past due support amount owed as allowed by Section 443.051(b)(2), Florida Statutes.

IV. The Respondent/Defendant shall provide DOR and the Court depository with his social security number and source of income and, further, he shall notify the Court depository of any change in his residence address, mailing address, employer and sources of income within 7 days of such change.

V. The Bureau of Vital Statistics Amendment Unit of the Department of Revenue is directed in those actions for paternity brought pursuant to Chapter 742, Fla. Stat., to issue a new birth certificate for the child(ren) born out of wedlock to reflect the Respondent/Defendant as the legal and natural father of the child(ren).

VI. An Income Deduction Order shall be entered as required by Sec. 61.1301, Fla. Stat. (1986) to be effective immediately. The Department of Revenue shall certify appropriate cases to the Internal Revenue Service, Florida Lottery and to the Unemployment Compensation Bureau to collect unpaid Court ordered child support.

VII. Bonuses subject to Income Deduction: Pursuant to Section 61.1301(1)(b)(4), Fla. Statutes, the employer/payor of income shall deduct the entire amount of income paid in the form of bonus or other similar one-time payment, up to the amount of child support arrearage, and forward the payment to the Court depository. If the bonus exceeds the outstanding arrearage or other obligation, the difference shall be refunded to the Respondent/Defendant.

VIII. The Petitioner/Plaintiff shall provide DOR his/her address and social security number.

IX. If it is reasonably available, or becomes available in the future, the Respondent/Defendant shall obtain and maintain health insurance for the child(ren) and shall provide proof to the Child Support Enforcement Program within thirty (30) days of the effective date of the Court Order, that the insurance has been obtained or that application for the insurance has been made. Reasonably available is defined as coverage available to the Respondent/Defendant through his employer or a group plan. (Section 61.13(1)(b)(12), Florida Statutes). Proof of insurance is defined as a copy of insurance policy, insurance I.D. card or insurance application.


