It is adjudged that the Plaintiff, SPRINGLEAF FINANCIAL SERVICES OF AMERICA, INC. recover from the Defendant, LESLIE OWEN a/k/a LESLIE E. OWEN, the sum of \$5,524.22 as principal, late fees of \$10.00, \$718.99 as prejudgment interest, with costs of \$350.00, for a total of \$6,603.21, all of which shall bear interest at the rate of 4.75%, for all which let execution issue.
