



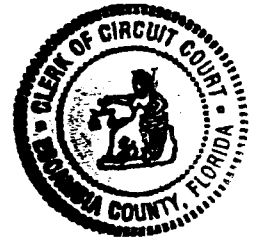

**FINAL JUDGMENT**

This Cause, came on to be heard upon the Plaintiff's Motion for Final Judgment, and the Court finds that the Defendants, Shiloh Kay Hoffert, AKA Shiloh Kay Maher and Charles Conrad Frantz, are indebted to Plaintiff in the principal sum of \$7,298.99 and prejudgment interest in the sum of \$473.51. The Court further finds that Plaintiff is entitled to recover its taxable costs in the amount of \$390.00.

It is ORDERED and ADJUDGED that the Plaintiff, State Farm Mutual Automobile Ins. Co., as Subrogee of Susan W. Mather recover from Defendants, Shiloh Kay Hoffert, AKA Shiloh Kay Maher and Charles Conrad Frantz, whose Social Security Number(s) are [REDACTED] and xxx-xx-3046, the principal sum of \$7,298.99, prejudgment interest of \$473.51 plus costs herein taxed at \$390.00, for a total sum of \$8,162.50 that shall bear interest at the rate of 6.00% for all of which let execution issue.
