
**CIVIL LIEN**

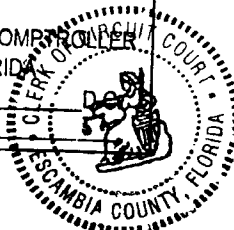
