MORTGAGE

THIS MORTGAGE dated March 8, 2006, is made and executed between **ROBERT B ROBERSON**, whose address is 3920 SCHIFKO RD, CANTONMENT, FL 32533-7025; **A MARRIED MAN** (referred to below as "Grantor") and **REGIONS BANK**, whose address is 50 BEVERLY PARKWAY, PENSACOLA, FL 32505 (referred to below as "Lender").

GRANT OF MORTGAGE. 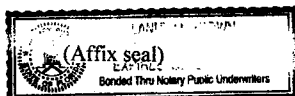

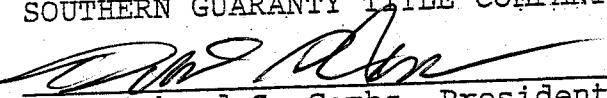
