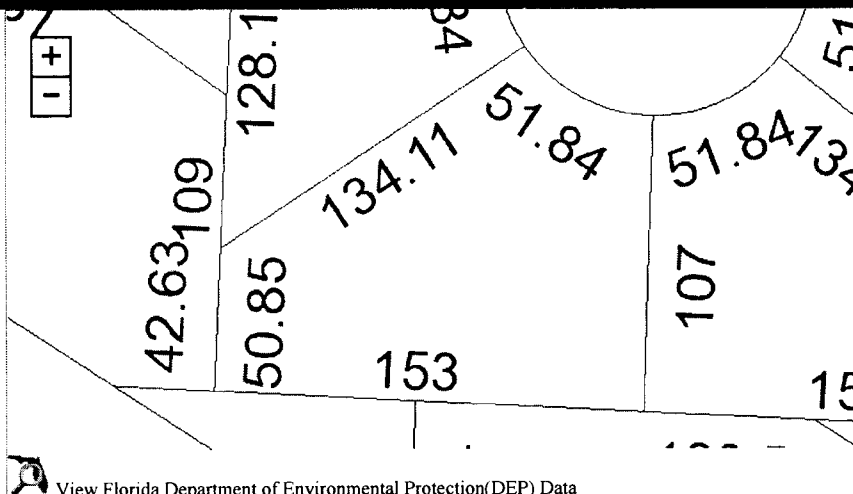


CIVIL LIEN
