

I understand that «County», Florida hereby retains a lien in the described property in the amount specified above. I understand the loan will be forgiven (depreciated) at a rate of twenty percent (20%) per year over the five-year (5) period. This five-year (5) period begins on «date_cl_sht», the date the Contract for Housing Rehabilitation Services is signed. The loan is completely forgiven after the five (5) year period.

If the property is sold, owner(s) and/or their heirs agree to repay that portion of the five-year (5) period that remains unforgiven (undepreciated). The unforgiven portion will be paid in a lump sum from the proceeds of the sale of the rehabilitated property.
