ORDER

The County's Motion for Additional Temporary and Permanent Injunction came on for hearing before the Court on February 23, 2007.

Based on representations by counsel for the Parties, and counsels' statement of agreement as to the content of this Order, the Court finds that:

1. Defendant Hethington does not have either the equipment or financial resources to respond to or control a fire at the Bankhead Facility;
2. Pursuant to its police power, Escambia County has the right and duty to protect the public against the dangers of fire; and
3. In consideration of Mr. Hethington's inability to respond to or control fires at the Bankhead Facility, the actions authorized herein constitute a public purpose, which authorizes the expenditure of public funds.

NOW THEREFORE, it is ORDERED that Escambia County, and its officers, employees and agents, may enter the property described in Attachment "A" (the "Bankhead Facility"), for the following purposes:

1. To respond to any active or on-going fire;

THIS CAUSE having come before the Court on February 26, 2008, and the Court having
taken testimony, having heard the argument of the parties, and being otherwise advised,

IT IS HEREBY ADJUDGED:

1. Defendant Keith A. Hethington is liable for the violations alleged in Counts I and
III of the Department's Amended Complaint and Petition for Enforcement.
2. Defendant allowed open burning of solid waste in violation of Section 403.161, Fla.
Stat. and Chapters 62-701 and 62-256, Fla. Admin. Code.
3. Defendant has failed to construct a stormwater management system in violation of
Section 373.430, Fla. Stat. and Chapter 62-25, Fla. Admin. Code.
4. Defendant has failed to close the Ambush Land Clearing Debris Disposal Facility
"Facility" within 180 days after final receipt of wastes, in violation of Section 403.161, Fla. Stat.
and Rules 62-701.803(10) and 62-701.803(11), Fla. Admin. Code.

5. Defendant has failed to pay \$4,000.00 in penalties and \$1,000.00 in costs assessed in the Final Order, and has failed to complete any of the Corrective Actions required by the Final Order.

6. Section 403.141(1), Fla. Stat., authorizes the Court to impose civil penalties of not more than \$10,000 per day per violation. Additionally, Section 403.161(6), Fla. Stat., states "[i]t is the legislative intent that the civil penalties and criminal fines imposed by the court be of such amount as to ensure immediate and continued compliance...."

7. Plaintiff is not entitled to relief under Count II of the Department's Amended Complaint and Petition for Enforcement. The active life of the permit terminated on February 6, 2007, and therefore the alleged facility access control violations are not sanctionable.

WHEREFORE, IT IS HEREBY ORDERED that:

A. In accordance with the claims set forth in the Amended Complaint and Petition for Enforcement, the following relief is ORDERED:

1. A mandatory injunction is issued requiring Defendant Keith A. Hethington to close the Ambush Land Clearing Debris Disposal Facility in accordance with Rules 62-701.803(10) and 62-701.803(11), Fla. Admin. Code within 120 days of entry of this Judgment. Defendant shall place final cover on the facility, and shall seed or plant vegetative cover. Final cover shall consist of a 24-inch thick soil layer, the upper six inches of which shall be capable of supporting vegetation and shall be graded to eliminate ponding, promote drainage, and minimize erosion. The side slopes of all above-grade disposal areas shall be no greater than three feet horizontal to one foot vertical rise. Defendant shall notify the Department within 30 days after closing, covering, and seeding

the facility, as required by Rule 62-701.803(10). This time may be extended by the Court, upon motion by the Defendant, in order to effectuate the stormwater management plan.

2. A mandatory injunction is issued requiring Defendant Keith A. Hethington to develop a stormwater management plan and submit it to the Department's Northwest District Office for approval, with a copy to the Court and a copy to Escambia County, Stormwater Manager, Attention Doyle Butler, within 90 days of entry of this Judgment. The stormwater management plan shall conform to the requirements of Chapter 62-25, Fla. Admin Code. Defendant shall construct the stormwater management system within 90 days of Department approval of the stormwater management plan.

B. The Department is hereby granted site access to the Ambush Land Clearing Debris Disposal Facility, located south of Bankhead Road approximately ¼ mile west of the Bankhead Road and Blue Angel Parkway intersection in Escambia County, Florida to verify compliance with the terms of this Judgment.


C. Judgment is entered in favor of Plaintiff, State of Florida Department of Environmental Protection, located at 3900 Commonwealth Boulevard, Tallahassee, Florida, 32399, and against Defendant Keith A. Hethington, whose social security number is [REDACTED] and who resides at 497 North 70th Avenue, Pensacola, Florida, 32506, in the amount of \$12,500.00, for which let execution issue. This consists of \$1,000 in costs; \$4,000 in civil penalties awarded by Administrative Law Judge P. Michael Ruff in his Final Order of April 20, 2007; and \$7,500 in civil penalties awarded for the violation alleged in Count I of the Department's Amended Complaint and Petition for Enforcement. Payment shall be made by cashier's check or money order payable to the "State of Florida Department of Environmental Protection" and shall include the notations "Ecosystem Management and Restoration Trust Fund"






ORDER

The County's Motion for Additional Temporary and Permanent Injunction came on for hearing before the Court on February 23, 2007.

Based on representations by counsel for the Parties, and counsels' statement of agreement as to the content of this Order, the Court finds that:

1. Defendant Hethington does not have either the equipment or financial resources to respond to or control a fire at the Bankhead Facility;
2. Pursuant to its police power, Escambia County has the right and duty to protect the public against the dangers of fire; and
3. In consideration of Mr. Hethington's inability to respond to or control fires at the Bankhead Facility, the actions authorized herein constitute a public purpose, which authorizes the expenditure of public funds.

NOW THEREFORE, it is ORDERED that Escambia County, and its officers, employees and agents, may enter the property described in Attachment "A" (the "Bankhead Facility"), for the following purposes:

1. To respond to any active or on-going fire;
2. To enter onto the Bankhead Facility for the purpose of determining whether conditions at the Bankhead Facility may create a danger of fire; and
3. To take reasonable action deemed necessary by the County Administrator, or his designee, to protect adjoining property owners from the danger of fire, to include, without being limited to, the placement of additional fill dirt on the Bankhead Facility.

The Court reserves jurisdiction to determine whether, under the current pleadings, Escambia County is entitled to recover costs or damages from Mr. Hethington.

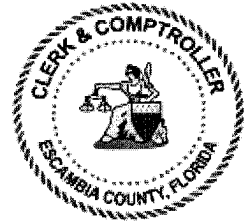
