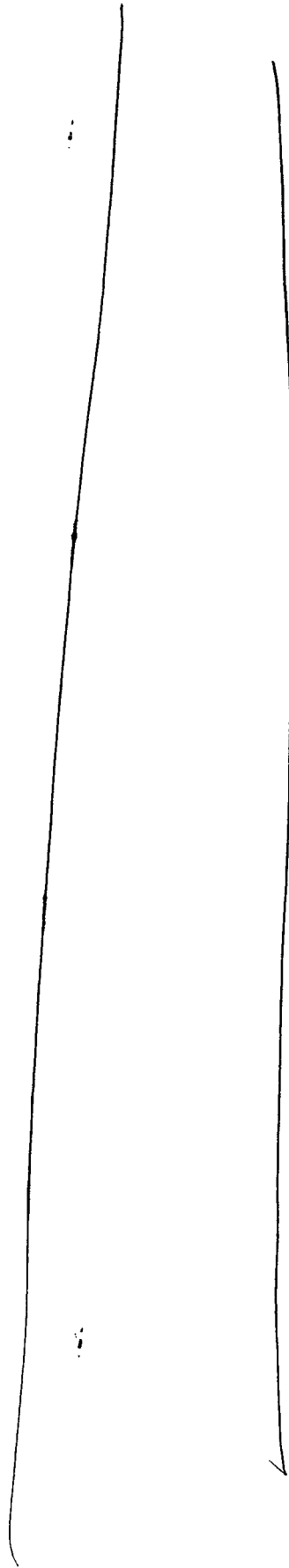

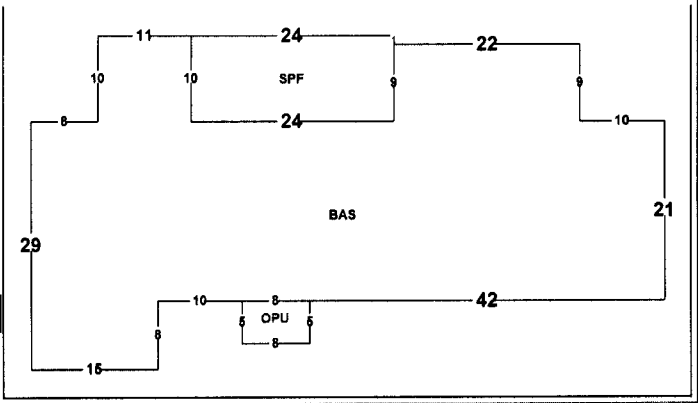

GUNN FAMILY TRUST

This is a trust agreement dated this 19th day of October, 1999, between EARNESTINE GUNN and WALTER E. GUNN (referred to as "Grantors") and EARNESTINE GUNN and WALTER E. GUNN, or their successors, as trustees (collectively referred to as "Trustee") and shall be referred to as the GUNN FAMILY TRUST.

ARTICLE I

Original Trust Estate. Grantors transfer and deliver to Trustee the property owned by them individually, as joint tenants with right of survivorship, as tenants by the entirety, as tenants in common and any other property that the Grantors wish to be deemed joint property (collectively referred to as "the trust property"), all as listed in Schedule A.

ARTICLE II

Additional Property. Subject to acceptance by Trustee, Grantors, or any other person, may from time to time add cash, securities, insurance policies, or other property to the trust estate or any trust share by deed, gift, or will. The additional assets will be held, invested, administered and distributed according to this Agreement, except to the extent expressly provided to the contrary in the instrument of transfer.

ARTICLE III

Rights Reserved by Grantors.

A. Alteration, Revocation, or Amendment. Except as otherwise specifically provided to the contrary in this agreement, each Grantor reserves the right and power to alter, amend, or revoke this trust agreement, with respect to the trust property any time and from time to time, without the consent of Trustee or any person, by giving written notice to Trustee to that effect.

B. Suspension of Grantors' Rights. If, at any time during the continuance of this trust, either or both Grantors are adjudicated incompetent by a court of appropriate jurisdiction, or either or both are deemed incompetent by two licensed medical doctors and the Grantor's spouse, if competent (or the Grantor's children if the spouse is deceased or incompetent), that Grantor's (or the Grantors', as the case may be) personal powers of alteration, amendment, revocation, and withdrawal will be suspended during that incompetency. If at any time either Trustee (or the named successor Trustee, as appropriate) has a reasonable basis to believe that either or both Grantors are suffering from any

list and any subsequently discovered statement or list shall be of no force and effect.

E. Grantor WALTER E. GUNN may leave a signed written statement or list disposing of certain items of tangible personal property not otherwise disposed of herein. Grantor WALTER E. GUNN gives those certain items of tangible personal property owned by his share of this trust at the time of his death in the manner described in the last dated writing made for this purpose and signed by him that is in existence at the time of his death. Any such statement or list will probably be found in his safe deposit box, or with the original or a copy of this Trust. If no such written statement or list is found and properly identified by the Trustee within thirty (30) days after WALTER E. GUNN's death, it shall be presumed conclusively that there is no such statement or list and any subsequently discovered statement or list shall be of no force and effect.

ARTICLE VI

Distribution after Death of Surviving Grantor. Upon the death of the surviving Grantor, Trustee shall make provision out of the trust for the payments, purchases and loans described in paragraph A and paragraph B of Article V, if any.

A. The Trustee shall distribute the Grantors' homestead to WILLIAM MARK GUNN if he is then living and if he is not to WILLIAM TRAVIS GUNN. For purposes of this trust we hereby declare the value of the homestead to be \$50,000.00.

B. The remaining trust assets shall be divided into equal trusts so as to provide one trust for each of our then living children. The trust established for WILLIAM MARK GUNN shall have subtracted from it the \$50,000.00 value placed on the home and this amount shall be split between all of the trusts. During the life of a child the trustee shall distribute to the child all of the net income of his or her trust and as much of the principal of the trust so retained as the trustee believes desirable for the health, support in reasonable comfort, education, and maintenance of the beneficiary for whom the trust is named, considering all circumstances and factors deemed pertinent by the trustee. Any undistributed net income shall be accumulated and added to principal, as from time to time determined by the trustee. Upon the death of the child his or her trust shall be added to the trusts for our remaining children and upon the death of the last child the remaining trust assets shall be distributed to our then living grandchildren, per stirpes.
