



#### FINAL JUDGMENT

The Court having heard the extensive testimony of the parties and their respective witnesses, having reviewed the business records kept before, during and subsequent to the relevant and material time period, and being otherwise advised in the premises finds as follows:

The Court was impressed by the Plaintiff and his witnesses' earnestness and position in the matter. He maintained steadfastly that if not for his efforts, including personal loans to the club, the club would have virtually ceased to exist; apathy, distrust and disorganization, among other matters, having eroded the basis of its existence.

The Defendant argues that the club did well before the Plaintiff took the reins - that it went downhill to the point that member participation came to a minimum, that the Plaintiff thereafter had virtual free reign for some months during which time the club lost thousands of dollars - and that finally the members took back control and as a result thereof the club is once more thriving and profitable. Plaintiff points out that he worked at a tremendous disadvantage because of the member apathy and that his efforts to raise money fell on deaf ears; that he was constantly a day late and a dollar short and because of this he could never quite get things profitable despite doing a reasonable business, and that he was not surprised to hear that the club is now in the black (as a result of an infusion of sufficient capital by the members).
