

#### FINAL JUDGMENT

THIS MATTER came on for final hearing in chambers on December 14, 2001 and was continued and completed on March 25, 2002. The Court, having considered the testimony, exhibits and arguments, concluded that judgment should be entered as set forth below.

The Court finds that the parties agreed to a settlement of Defendant's account with Plaintiff as of February 5, 2001 and then agreed to a credit to the account thereafter. Thus, Plaintiff established his claim against the Defendant in the amount of \$743.48 for merchandise, plus \$682.24 for tools purchased, together with prejudgment interest thereon in the amount of \$160.46 from March 7, 2001, together with the costs in the amount of \$114.50 for a total of \$1,700.68 together with interest thereon at the rate of 9% per annum from the date hereof, for all of which let execution issue.

#### **FINAL JUDGMENT**

THIS MATTER came on for final hearing in chambers on December 14, 2001 and was continued and completed on March 25, 2002. The Court, having considered the testimony, exhibits and arguments, finds that judgment should be entered as set forth below.

The Defendant sets up as his primary defense the longstanding principle that, in general, contracts for professional services entered into by persons unlicenced in violation of state statutes cannot be enforced. That position, of necessity precludes the Defendant here prevailing on his claims of quantum meruit and unjust enrichment. To hold otherwise would be to permit an unlicenced person to circumvent the requirements of the statute and the principle of law simply by bringing claims on another theory and thereby defeating the public policy that underlies the principle. A review of the contract, admitted as Plaintiff's Exhibit 1 shows that the parties agreed that the Plaintiff would obtain any permit, if necessary. This in turn implies that the parties were aware that the Defendant was not a licensed contractor. The Court therefore concludes that the principle described above with respect to the unenforceability of contracts under such circumstances governs with respect to the Statement of Claim as well.

Accordingly, judgment herein is entered in favor of the Defendant as to the Statement of Claim and in favor of the Counterdefendant as to the Counterclaim.
