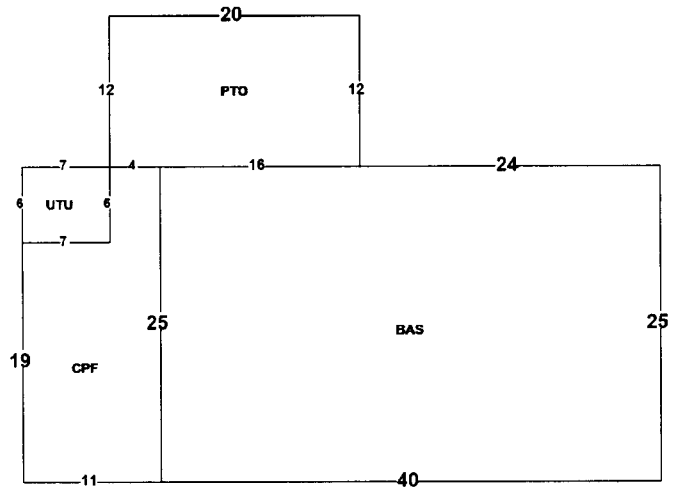

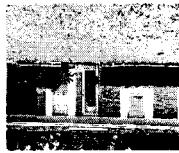

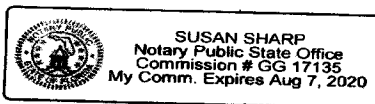

This judgment shall bear interest at the rate of 6% simple interest per annum.

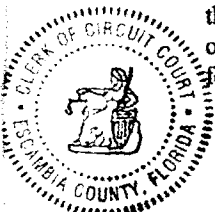
