LEVITAN, SR., whose address is 511 Windrose Circle, Pensacola, FL 32507, the sum of **\$1,184,350.41** (consisting of the principal sum due as of January 22, 2018 in the amount of \$1,000,000.00, and prejudgment interest from January 22, 2018 through January 6, 2021 in the amount of \$184,350.41), which shall all bear interest at the statutory rate as set forth in Section 55.03, Florida Statutes, which is presently 4.81% per annum, and *for all of which let execution issue.*
10. It is further order and adjudged that Defendant shall take nothing on his Counterclaim, and that Plaintiff shall go hence without day with respect to the Counterclaim.
11. It is further ordered that Defendant, John D. Levitan, Sr., shall complete the Fact Information Sheet that is attached hereto within forty-five (45) days and shall provide the completed Fact Information Sheet to Plaintiff's counsel at the address below.

2. The Contract pertained to the sale of an entity named LDRK Capital, LLC, which owned the Brazilian Treasury Bonds ("LTN bonds") that are described in the Contract.
3. Defendant's Counterclaim (filed on March 2, 2020) seeks damages based on allegations that he relied on Plaintiff's representations regarding LTN bonds. More specifically, Defendant contends that the bonds were fraudulent and counterfeit and were without value. As such, Defendant alleges that he was deprived of the value of the transaction and suffered damage. (Counterclaim, ¶¶ 2-6.)
4. No term of the Contract conditioned Defendant's obligation to pay the \$1,000,000 that was owed to Plaintiff by Defendant pursuant to the Contract on the value of the LTN bonds.
5. The Contract contains the following provision that pertains to the LTN bonds:

John D. Levitan, acknowledges that he independently reviewed the information posted on the website www.tesouro.fazenda.gov.br prior to this agreement and that no representations as to the Market Value were made by Lucian G. Dancasescu and John D. Levitan, Sr. interest in these bonds is strictly speculative.

6. Plaintiff's Motion for Summary Judgment moved for entry of a summary final judgment on both Plaintiff's claims and Defendant's Counterclaim.
7. The Court finds that the plain and unambiguous language of the Contract expressly disclaimed any representation regarding the value of the LTN bonds inasmuch as it provided that "no representations as to the Market Value" of

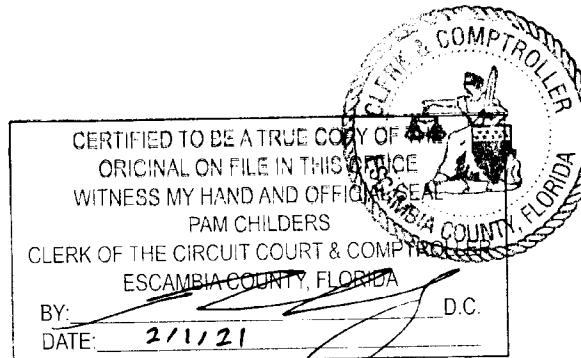

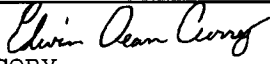

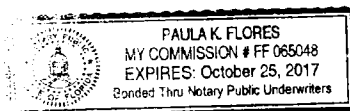
