FINAL JUDGMENT

At a final hearing in open court on September 17, 2010, the plaintiff appeared with counsel and the defendants appeared representing themselves. This case concerns credit extended to the defendants by plaintiff. They do not dispute that they asked for and accepted the \$5,000.00 loan. Instead, they argue that they agreed to a "fixed rate" loan not a "variable rate" loan.

Plaintiff admitted into evidence through the custodian of records, a copy of the contract signed by both defendants which clearly reflects variable rate terms. Further, defendants were sent monthly billing statements on this account which reflect the "variable" rate. It is undisputed that the defendants never filed any written disputes to the monthly statements. It is only now that they raise the dispute over the rate charged. They claim that their signatures on plaintiff's exhibit #1 are either forgeries or a "cut and paste" job, but have no good faith basis to raise the claim or evidence to support their claim.
