

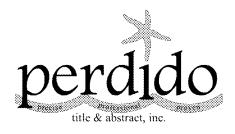

THIS CAUSE having come before the Court for final hearing on April 23, 2015 and telephone conference on July 17, 2015 with counsels for Plaintiffs Douglas Hager and Debra Hager and Defendant Tonya Lee Moore present, the Court having heard argument of counsel, testimony of Plaintiff Douglas Hager, having reviewed the pleadings, causes of action, prevailing party attorney's fees and costs, memoranda, and finding good cause to

- 2. Patent and latent ambiguities existed in the Contract and Agreement on the amount owed; however, the intent of the parties was to enter into an agreement to pay \$53,000 at 11% per annum with a 15-year amortization period for the subject property, for a total of \$108,431.35 (\$53,000 in principal and \$55,431.35 in interest).

- 3. Plaintiffs have received a total of \$105,342.93 from Defendant Tonya Lee Moore.
