**FINAL JUDGMENT UPON THE FORMER WIFE'S MOTION FOR CIVIL
CONTEMPT/ENFORCEMENT**

THIS CAUSE came before the Court on August 13, 2015, for hearing upon the Motion for Civil Contempt/Enforcement filed by the former wife on July 2, 2014. The former wife personally appeared before the Court, pro se. The respondent appeared telephonically, pro se.

The Final Judgment of Dissolution of Marriage entered on October 3, 2008, required the former husband to pay to the former wife \$200.00 per month bridge-the-gap alimony for a period of 18 months. The former wife testified the former husband failed to make any payments. The former husband testified he did not make any payments but that he also believes he should not have been required to pay her.

The former husband is unemployed, suffered a spinal injury, and is in a nursing home due to an accident that has left him significantly paralyzed in his arms and legs. The former husband receives social security disability which is currently paid to

the nursing home. The former husband has a pending lawsuit as it relates to his spinal injury. Based on the foregoing, it is hereby;

ORDER AND ADJUDGED:

The alimony arrearage is established at \$3600.00. A lien is hereby placed against the net proceeds that the former husband, Michael Harris, is to receive from his pending spinal injury lawsuit in an amount that is not to exceed the provisions of this Judgment.

Judgment is hereby entered against the former husband, Michael Harris, in favor of the former wife, Cynthia R. Salter, for the sum of \$3600.00, which shall accrue interest at the statutory rate for all of which let execution issue.




