



Without limitation or redefinition, the terms "third-party benefits", "assigned rights", and "collateral" include any claim, cause of action, proceeding, judgement or award against any person sought to be held liable for tort, personal injury, wrongful death, medical malpractice, workers compensation or for payment of medical expenses, or for coverage for liability, no-fault, personal injury protection or uninsured motorists and include any settlement, settlement agreement, and any proceeds.
- 4. By statute, only one claim of lien need be filed to provide notice as to any Medicaid

payments made after the date of this claim of lien or as to amounts in addition to the amounts stated herein. 409.910(6), Fla. Stat.

- 5.
