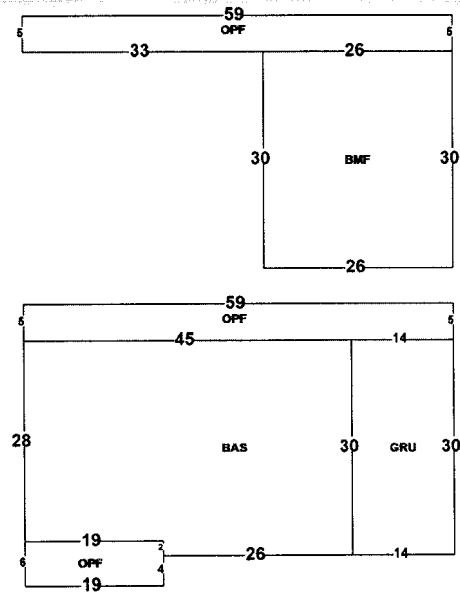

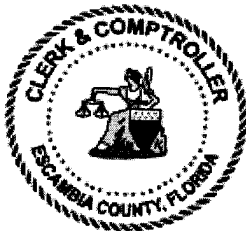

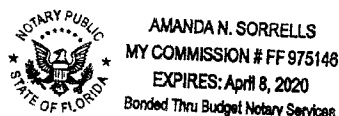

**FINAL JUDGMENT**

At a Small Claims Pretrial Conference on September 10, 2021, the parties appeared and entered into a court-ordered payment plan. The Plaintiff has now filed a Motion for Final Judgment in that the defendant has failed to comply with the terms and conditions of the Agreement. The court, having reviewed the Affidavit filed in support of the motion, finds that the plaintiff is entitled to a Final Judgment, it is hereby,

ORDERED AND ADJUDGED that Plaintiff's Motion for Final Judgment is hereby GRANTED in favor of OLIPHANT FINANCIAL, LLC C/O Hodges, Avrutis & Foeller, P. O. Box 4137, Sarasota, FL 34230. Plaintiff, OLIPHANT FINANCIAL, LLC shall recover of and from Defendant, ELIZABETH MYERS, the sum of \$2,822.52 on principal, costs in the sum of \$ 430.85, plus charged off fees of \$15.00, and pre-judgment interest of \$ 135.13, less payments of \$- 450.00, for a total of \$3,953.50 with interest accruing at the prevailing statutory interest rate of 6.580% per year from this date through December 31 of this current year, for which let execution issue.
