





It is hereby **ORDERED** that the **RESPONDENT(S)** shall have until 8/8/2024 to correct the violation(s) and to bring the violation into compliance. Corrective action shall include:

Complete removal of all contributing nuisance conditions; trash, rubbish, overgrowth and legally dispose of maintain clean conditions to avoid a repeat violation.






