
### FINAL JUDGMENT

Defendants were previously married and obtained a Bank of America Visa among other credit cards. Mr. Elliott candidly testified that he applied for and obtained the credit cards so that they would have them for an emergency. Apparently, his soon to be ex-wife, Tina Elliott, felt that their separation and pending divorce constituted an emergency and she made various charges to this card. A Default Final Judgment has already been entered against Tina M. Elliot, but Mr. Elliott wished to contest his liability for this account since he did not personally make the charges.

Because he candidly admits this was his credit card, he is liable for the credit extended. Regardless of any arrangements made in the divorce decree for division of liabilities and assets, without a release from Bank of America, both defendants would be equally liable for the debt. The court appreciates Mr. Elliott's candor and his hard work in preparing his case for trial.

ORDERED AND ADJUDGED that plaintiff shall recover from defendants jointly and severally \$1,459.12 as the principal sum due plus attorney's fees and costs in the amount of \$1,085.00 and interest in the amount of \$705.90 all of which shall accrue interest at the rate of 11% per annum for which let execution issue.
