On JUNE 28, 2021, an order assessing fines, costs, and additional charges was entered against the Defendant, CARL VON OGLETREE. Defendant has failed to make payment in full in accordance with this order. Therefore,

IT IS ADJUDGED that the Escambia County Clerk of the Circuit Court, 190 W GOVERNMENT ST, PENSACOLA, FLORIDA 32502 recover from Defendant those remaining unpaid fines, costs and additional charges in the amount of \$975.00, which shall bear interest at the rate prescribed by law, 4.31%, until satisfied.
