



This ignores the plain and simple language of the written agreement defendant signed when she opened the account. Therefore it is

ORDERED AND ADJUDGED that plaintiff shall recover from defendant \$3,482.00 plus court costs of \$33000 which shall accrue interest at the rate of 8% per annum for which let execution issue.


