It is hereby **ORDERED** that the **RESPONDENT(S)** shall have until **11/24/2022** to correct the violation(s) and to bring the violation into compliance.

Corrective action shall include:

Complete removal of all contributing nuisance conditions; trash, rubbish, overgrowth and legally dispose of. maintain clean conditions to avoid a repeat violation.

FINAL JUDGMENT

At a final hearing in open court on March 15, 2012, the plaintiff appeared but the defendant did not. Later that same afternoon, the plaintiff arrived at the courthouse and filed a motion for rehearing stating she had a flat tire and could not make it in time for court. The motion was marginally legally sufficient but because the law favors resolving cases on their merits rather than a technicality, the final judgment was set aside and the trial reset for April 27, 2012, and notice provided to both parties giving about six weeks notice. The day before the trial, the defendant called stating that she was out of town and could not be present in court. She refused to give a reason for her inability to appear, and merely stated that she was "out of the state." She was informed that without a legally sufficient reason for her failure to appear, the case would once again be resolved without her.

On April 27, 2012, in open court, the plaintiff appeared but the defendant did not. This is the second time this case has been set for trial and the defendant has failed to appear. The plaintiff testified under oath that the defendant was his landlord and she wrongfully withheld his security deposit and prepaid rent. Therefore it is

ORDERED AND ADJUDGED that plaintiff shall recover from defendant \$583.34 plus court costs of \$350.00 all of which shall accrue interest at the rate of 4.75% for which let execution issue.


