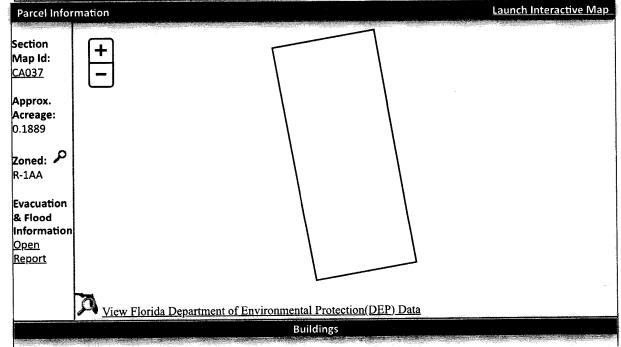

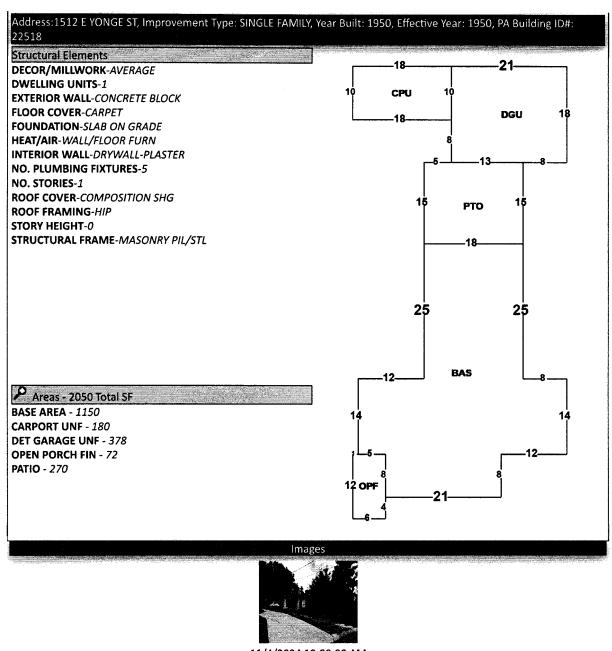

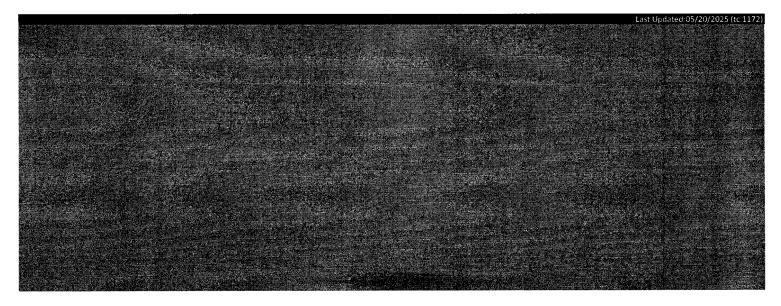

THIS CAUSE came before the Court for plea on September 28, 2006. Upon the evidence presented, the Court assessed \$110.00 for Cost of Supervision Arrears, and 50.00 for Hearing fee. Therefore, the Court determines that \$160.00 is due to Department of Community Corrections. Accordingly, pursuant to the provisions of \$938.30. Florida Statutes. it is,

ORDERED AND ADJUDGED that the above-named Defendant shall pay cost of supervision arrears to the Department of Community Corrections, in the amount of \$160.00 which shall accrue interest at the rate of nine percent (9%) per annum.

ORDERED FURTHER that nothing in this Civil Lien will bar any subsequent civil remedy or recovery, but the amount paid under this order shall be a set-off against any subsequent independent civil recovery. Any default in payment of the amount due hereunder may be collected by any means authorized by law for the enforcement of a civil judgment, for which let execution issue.
